III. Consideration of Approval of January 12, 2021 Planning Commission Meeting Minutes

IV. Comprehensive Plan Review – Lake County Watershed Development Ordinance Amendments

Chairman Weiner noted that he would talk to President Yeaton about putting future plans for a turnabout into the Comprehensive Plan.

The Plan Commission reviewed the draft copy of various changes/updates as discussed at the previous meeting. Under Road and Salt Storage Facility, there was discussion about how the village street salt is being contained and if the enclosure is within compliance with State guidelines. It was recommended to confirm this information with Public Works Director Rusty Issleb and to update the full section accordingly.

Kotarski offered to rewrite the full section under Establish a Community Room/Police Office with language acknowledging the new community center.

It was recommended to add a link to the Lake County Watershed ordinance.

It was pointed out that the Algae Control be listed under Surface Water.

Under Services, update items 5 and 6 with more specific information, It was questionable whether or not to note code enforcement with Wauconda.

It was recommended to add a link to Tree City USA.

It was recommended to add updated pictures of the newly renovated exterior of the village hall building and new community room and garage (outside and inside). Take out winter pictures shown on the ordinance page. Incorporate photos from the current plan into the draft updated plan, excluding some of the outdated and others omitted per discussion.
