LAKE AND MCHENRY COUNTIES, ILLINOIS
October 1, 2025**

President Vogeler called the monthly Committee Meeting of the Board of Trustees to order at 7:17 pm. The following Trustees were present; Tuke, Jurkowski, Grothendick, Lawrence and Suddeth. Trustee Corrigan was absent.

Minutes of the September 3, 2025 Committee Meeting were before the Board. Trustee Grothendick motioned to approve. Trustee Jurkowski seconded. Roll call was taken: 5 Ayes, 0 Nays, 1 Absent. Motion approved.

PLANNING COMMISSION

The event with Citizens for Conservation went well and was well attended.

HEALTH AND SAFETY

Trustee Lawrence stated there was no new information on the Challenge Coins. Leaf vacuuming is scheduled for October 28th and November 18th.

Trustee Grothendick stated that weed cutting in the channels was performed the week prior and it was the last session for the season.

STREETS AND ROADS

President Vogeler read from comments written by Trustee Corrigan and stated that crack sealing was complete. One area on Circle Avenue needs work and Manhard is working with Patriot to correct.

A resident emailed that she drove over the crack seal and it damaged her tires by sticking to them. There has been no recent contact.

Trustee Corrigan wrote that he received notification that the Federal Government closing would have no affect on approvals for funding.

FORESTRY

Rusty is watering the newly planted trees.

PARKS AND RECREATION

Trustee Suddeth stated that Riverfest was well attended and the bands were well received. He thanked the volunteers and the REC committee for another successful event. Georgina Lamb stated the donations from LRS and the Broken Oar are still coming. Trustee Jurkowski will meet next week for a recap of expense and income.

The next event will be the Halloween party on October 26, 2025 and trick or treat.

The Chili Cook-off will be the 2nd Sunday in November.

President Vogeler suggested using tents for both events.

COMMUNITY RELATIONS

BUILDING AND ZONING

Trustee Jurkowski stated that the No Wake is now in compliance with requests to obtain permits and correct issues.

FINANCE

Trustee Grothendick stated there are 6-month reviews coming up for budgets.

President Vogeler and Trustee Grothendick will meet to consider designs for the digital sign.

Vehicle Tax income this year is at \$21,060.00. There are 75 non-compliant homes with fines that should be sent to collections. The Board agreed on the step to send to collections.

ADMINISTRATION

Donna Erfort stated that reports are coming due, including the NPDES.

VILLAGE ATTORNEY

Lisa Waggoner is working on the compliance for Moorings emergency access road.
