**IV. 2026 Planning Commission Meeting Calendar**

The PC reviewed the prepared draft 2026 meeting calendar for approval.

***Motion: Kotarski moved to accept the draft 2026 meeting schedule as presented, moved by Bergbauer. All Ayes/None Nays/One absent – Motion Carried 6-0***

Bergbauer noted that he would not be at the February meeting. Russo noted that he'd be absent for March meeting.

**V. Update Roberts Road Roundabout**

Russo noted that he's researched with Lake County that there is consideration for a budget for a roundabout at Roberts Road. There was also discussion regarding a pedestrian bridge across Roberts Road. Russo noted that he reached out to Trustee Corrigan. A bridge could provide access to future development on the Sherman Property and bike trail.

Russo pointed out the directional sign pollution at the existing roundabout further south on Roberts Road would not be necessary for this one.

**VI. Rerouted Bike Way**

There was no update at this time. There was a brief discussion about supporting the proposed bike trail and it would assumedly cheaper to break away from the Cary Bike Trail.

There was discussion to look into pursuing retail homes, putting community land into a trust to let community invest into property, look into putting up “Tiny Homes”. There was discussion regarding changing and/or creating new zoning to accommodate the tiny housing?

There was discussion regarding Village AH shortfalls to provide any AH Housings. .

S.Alesi indicated that she will reach out to the Building Inspector to ask about how many roof solar panel permits have been requested/issued.

**IX. Future Native Planting Training and Information Sessions with Citizens of Conservation**

Chair Hallett needs to talk to the C of C to do future presentations regarding the river and channel restoration. Bergbauer noted that he’s talked to President Vogeler about this matter.

Russo suggested drilling a new well. Chair Hallett expressed her concerns of running out of water. Russo further suggested putting in a water tower.
